What is the purpose of this project; what specifically will it accomplish?

There is a genuine need for an enclosed walkway to connect our church and our Fellowship Hall so that it is possible to go between buildings without having to go outdoors. Our Fellowship Hall was completed approximately 10 years ago. Phase 2 of the project was to be an enclosed walkway but that project has not been undertaken due to lack of funds.

What problem is this project attempting to solve?

At the current time the only restrooms in our church are in the basement and are not handicapped accessible. If a handicapped person needs to use the restroom they have to use the restrooms in our Fellowship Hall which is 30 yards from the church and involves going outside. Our nursery is also located in the Fellowship Hall so our small children and babies have to be bundled up and walk or be carried to the Fellowship Hall when they go to the nursery.

Who else in the community is working on this issue? Please list all other groups and/or committees.

Our church has appointed a committee that has been working on the plans for this project.

How will the project be implemented and how will you coordinate with others working on this issue?

Church members that are working on this committee have already contacted a carpentry crew and stone masons that have studied and assessed the project and committed to overseeing the job. Along with these paid laborers we will also have members of the church and community that will volunteer their time on the project so we can keep the costs as reasonable as possible.

What local support is there for this project?

A large portion of our community will benefit from this project as our Fellowship Hall is used on numerous occasion for community functions. Our church is also offered to non-members for funerals and weddings. The walkway would be of huge benefit for those occasions when handicapped restroom facilities are often essential.
