## FIRST AMENDMENT TO AGREEMENT OF THE ROBERT W. BLACKBURN AND NEVA EDITH BLACKBURN LIVING TRUST UTA JUNE 27, 2012

Robert W. Blackburn, Settlor, and Robert W. Blackburn, Trustee, of the Robert W. Blackburn and Neva Edith Blackburn Living Trust UTA dated June 27, 2012, pursuant to the power of amendment given therein, make the following amendment to that Trust:

- I. Paragraph D of Section V. <u>DISPOSITION OF TRUST PROPERTY</u>, shall be and hereby is amended to read as follows:
- D.) After payment and settlement of the above, Trustee shall distribute the sum of Fifty Thousand Dollars (\$50,000.00) to each of the following charitable entities:
- 1.) The United Methodist Church, Council Grove, Kansas, with one-half (1/2) to be given to missions and one-half (1/2) to be used or expended in the discretion of the Board of Trustees.
- 2.) The Council Grove Area Foundation, Council Grove, Kansas, to establish a restricted, named fund in the names of Robert W. Blackburn and Neva Edith Blackburn, with as much of the principal sum as is possible to be held in trust in perpetuity, with the interest or earnings therefrom to be distributed for general charitable purposes as may be directed by the lineal descendants of Robert W. Blackburn and Neva Edith Blackburn.
- 3.) The Morris County Hospital Foundation, with such funds to be held or expended at the discretion of the Board of Directors of that entity for the benefit of the Morris County Hospital.
- II. The Agreement of Trust dated June 27, 2012, is hereby republished, ratified and reaffirmed in all respects, as modified by this First Amendment.
