What problem is this project attempting to solve?

The number one goal of CASA of the 8th Judicial District is to serve every Child In Need of Care eligible for our services. To accomplish this, more Volunteer Advocates are needed. CASA Volunteer Advocates make sure that the children we serve do not get lost in the overburdened legal and social service systems or languish in inappropriate group or foster homes. CASA Volunteer Advocates stay with each case until it is closed. For many abused/neglected children, their CASA Volunteer Advocate will be the one constant adult presence in their lives. Independent research demonstrates that children with a CASA Volunteer Advocate are less likely to spend time in long-term foster care, have fewer placements, and are 50% less likely to reenter care. According to Judge Jeanne Meurer of Austin, TX; "CASA is an invaluable partner in reducing upheavals and children obtaining safe, permanent homes" (http://www.casaforchildren.org/site/c.mtJSJ7MPIsE/b.5852953/k.79A1/JP_9__Meuer_Hathaway.htm). Our goal is to reduce this likelihood by having better trained and more CASA Volunteer Advocates to serve the at-risk children. These Volunteer Advocates will be directly supervised by our Morris County Case Supervisor and our Executive Director.

Who else in the community is working on this issue? Please list all other groups and/or committees.

CASA of the 8th Judicial District is the only agency allowed by law to provide services as appointed by the Judge. This avoids duplication of services and encourages collaboration with the many social agencies serving families.

How will the project be implemented and how will you coordinate with others working on this issue?

The grant will enable CASA of the 8th Judicial District to recruit, train and certify additional Volunteer Advocates and assign these Volunteer Advocates to children for who the Advocate is best suited. This will result in greater stability of the CASA placement, and improved court reports on behalf of the children. This will also result in greater sensitivity to the child and the child's needs by the CASA Volunteer Advocate. Success of the program will be measured by the increase in children served with CASA of the 8th Judicial District services, the increase in the numbers of CASA Volunteer Advocates who remain with the child they were assigned, the increase of children who will remain in their permanent placement, the reduction in the number of monitored cases, and the proper supervision of Volunteer Advocates.
